Dear Neighbor,

Last month, the U.S. Supreme Court's conservative majority struck down Roe v. Wade. As Americans, we know people should have the fundamental freedom to make decisions about their own bodies and health care. This ruling takes that freedom away, and lets partisan politicians decide if women have the right to control their own bodies.

Over 60% of Ohioans agree with the Roe v. Wade decision to allow access to abortion. Despite this, the same day it was overturned, a Republican law banning abortion after six weeks, a point when many women don't even know they are pregnant, officially took effect in Ohio.

House and Senate Democrats have proposed an <u>amendment</u> to Ohio's Constitution that would ensure all people have the freedom to make decisions about their bodies and health care. Americans have spent 50 years fighting for this right, and we are not giving up now.

Ohio BMV Update

Some BMV Services are now online at https://bmvonline.dps.ohio.gov/

As of June 27:

Ohioans may renew their four-year driver's license or identification card online.

Starting July 11:

Customers will be able to transfer a title when engaging in a person-toperson sale of a vehicle by using a new online title process, using the Ohio Title Portal.

New drivers will be able to take the driving knowledge test online, in order to receive a temporary permit. (The driving portion is still in person.)

Working to protect women and support families

Due to reproductive freedom being almost completely stripped away in Ohio, it is more important than ever to ensure we are protecting women's health and supporting our babies and families.

The legislative majority continues to prioritize partisan legislation that endangers women's health, such as bills like <u>House Bill</u> 598 and <u>Senate Bill 123</u>. These current pieces of legislation would completely ban abortion in Ohio without any exceptions for rape, incest or to protect the health of the mother.

I believe that people deserve the freedom to make their own decisions about their bodies. In addition to ensuring that women of Ohio have the freedom to make their own health care decisions, Democrats have introduced a comprehensive legislative plan that invests in families from the very beginning and ensures all babies have the resources they need to grow and thrive.

The legislative package includes bills to:

- · Eliminate the diaper tax;
- · Create the Infant Formula Tax Credit:
- · Establish the Ohio Safe Sleep and Baby Box Program;
- Require insurance coverage of medically necessary donor human milk;
- · Create the Infant Nutrition Protection Act;
- · Enact the Ohio Pregnant Workers Fairness Act.

House and Senate Democrats have also proposed an <u>amendment</u> to Ohio's Constitution that would ensure all people have the freedom to make decisions about their bodies and health care. We are working every day to ensure that families have the resources and complete information they need to maintain their health.

Heat wave highlights need for utility transparency



As the weather warms up and Ohio feels the effects of climate change, it is more important than ever to ensure that the state is prepped for a future of clean and sustainable energy sources.

You deserve transparency from your utility companies, especially when health, safety and essential services are on the line and extreme circumstances are at play. Our energy grid must be modernized and well prepared for major weather events to ensure consumer security.

Legislation to help with this effort includes:

HB 429: Energy Jobs & Justice Act

- Launch the state's largest economic development initiative in recent history by prioritizing clean energy jobs and environmental justice programs;
- Center equitable policy design to ensure clean energy benefits go to those most historically and disproportionately harmed by Ohio's regressive energy policies;
- Move Ohio towards a more equitable clean energy future by encouraging clean energy growth, energy waste reduction and curbing utility influence over policymaking and regulatory actions.

HB 389: Regards energy efficiency and peak demand reduction portfolios

- Reduce waste and save consumers money;
- Give utilities an avenue to design and implement energy saving programs, such as installation of smart thermostats, putting in less wasteful HVAC systems, and recycling old appliances.

Public Health Emergency Unwind and Assistance

There are many waivers and policies that were in place during the pandemic/Public Health Emergency that are expiring or changing. Programs include Supplemental Nutrition Assistance Program (SNAP), Medicaid, federal student loan payments, and more. Please make note of the following dates if they relate to you and your family. I have also included various contacts for organizations that may be able to assist you with additional resources. Please do not hesitate to contact me or my office if I can provide additional information or assistance.

Dates of note:

June 30, 2022:

- Waivers that expired include:
 - o the Seamless Summer Option (SSO) to offer school meals to all children at no charge, regardless of area or individual eligibility based on household income
 - o other waivers for out-of-school-time meals (whether afterschool, during summer vacation, or during pandemic-related closures), including non-congregate waivers to allow for grab-and-go meals through the Summer Food Service Program (SFSP) and the Child and Adult Care Food Program (CACFP)
- o These programs will continue through the summer via the Keep Kids Fed Act of 2022

July 15, 2022

 Expected renewal of federal Public Health Emergency from Department of Health and Human Services (HHS) for an additional 90 day period

August 15, 2022

- o Potential 60-day notice of non-renewal of federal Public Health Emergency
 - o If so, Ohio Department of Medicaid begins eligibility redetermination activities

August 31, 2022

o Federal student loan payments, collections on defaulted loans, and interest accrual expected to resume.

September 30, 2022

o WIC fruits and vegetables temporary benefit increase expected to expire

October 14, 2022:

- o Potential end of federal Public Health Emergency by HHS, or renewal through Jan. 2023
 - o End of Medicaid enhanced federal match agreement (eFMAP), Medicaid redeterminations begin
 - o End of expanded eligibility for SNAP for college students
 - Vaccine Emergency Use Authorizations would expire, impacting COVID treatments and vaccines
 - o End of telehealth and telemedicine waivers for some Medicaid and Medicare services
 - Final SNAP Emergency/Maximum Allotment for all households issued within 30 days
