This month, I had the privilege of meeting with constituents from Building Freedom Ohio, who are passionately advocating for the rights of those who have paid their debt to society, aiming to bring positive change to their families and communities. Additionally, alongside the Governor, Mayor Malik, and our County Executive, my Statehouse colleagues and I celebrated Akron's selection as an Innovation Hub for polymer research, a designation accompanied by \$31.25 million in state funding to support this vital project. Lastly, my staff and I had the opportunity to tour the United Way of Summit and Medina County facilities across Summit County. These experiences have reinforced my commitment to fostering collaboration and driving positive change, and I look forward to continuing this important work together.

Legislative Update: Fighting to Lower Property Taxes for Ohioans

As we all know, the rising cost of property taxes is a critical economic issue for Ohioans. Homeowners are searching for answers and are rightfully frustrated feeling the squeeze of higher property tax bills. My Democratic colleagues and I have solutions.

No one wants to pay more than their fair share in taxes. That's why tax-shifting is unfair. It funds giveaways for the wealthiest few, and cuts to local communities, shifting taxes away from the state onto local homeowners. It doesn't have to be this way! Together, we can support policies to unrig Ohio's tax system, so the state stops shifting the tax responsibility onto homeowners and local communities.

Below, you will find a brief summary of some of the bills my colleagues and I have worked on to help lower your tax bill and address this issue:

- HB 60 (Troy) Increases the homestead exemption for elderly or disabled homeowners and certain surviving spouses
- HB 263 (Isaacsohn/Hall) Freezes property taxes for qualified homeowners
- **HB 274 (Dell 'Aquila/Matthews)** For individuals who qualify and have owned their homes for more than 20 years, this bill increases the exemption from \$26,200 to \$50,000.
- **Joint Committee on Property Tax Review and Reform** This committee, proposed by Rep. Troy, is examining and identifying solutions to address some of the concerns with Ohio's property tax laws.
- **HB 645 (Isaacsohn)** Legislation authorizing a property tax circuit breaker benefit for eligible homeowners and renters whose property taxes, or portion of rent attributable to property taxes, exceeds 5% of their income.
