This upcoming Monday is Labor Day, an annual celebration, held the first Monday in September, to recognize the economic contributions of American workers. Although there is some dispute among historians to who official founded Labor Day, it was first celebrated in the late 1880s. Following the adoption of Labor Day as an official holiday by over twenty states, Congress passed an act on June 28, 1894 establishing Labor Day as a National Legal Holiday. Labor Day in Toledo has long been celebrated with an annual parade throughout Downtown in the Morning. For decades, men and women stood together and fought, sometimes sacrificing their lives, to improve workplace safety conditions, and so forth. So many things common in today's workplace including 40 hour workweek, overtime pay, unlocked fire escapes, are things many of us take for granted that would not be in place had it not been for America's labor movement. Celebrating Labor Day is important for many reasons, but here are two. First, our great country was built by the middle class and labor unions play a significant role in expanding the middle class and keeping it strong. Second, Labor Day is for the workers who dedicate so much of their time and effort into their profession to improve our country's quality of life for all. Ohio's redistricting process officially kicked off last month with the Ohio Redistricting Commission convening for the first time on August 6. Convening the Commission put in motion the reforms Ohio voters laid out when they unequivocally told lawmakers not once, but twice, to bring fair districts back to our state. In late August, the Ohio Redistricting Commission hosted a 10-stop statewide listening tour to hear directly

from Ohioans about what they think their districts should look like. Hundreds of Ohioans from Toledo to Rio Grande showed up and testified on the importance of creating fair districts to ensure better representation and allow people to have a real voice in their democracy. Democrats and Ohioans wanted to see us follow our constitutional duty to release a map and hold additional hearings by Sept. 1, but the Commission adjourned on August 31 with no map. We need the Commission to work together to draft a fair map that lives up to the spirit of the reforms Ohioans passed in 2015. It is imperative that the Commission approve a bipartisan map before the next deadline of Sept. 15.
