So far the start of Fall session in the Ohio House has been hectic and not very productive for Ohio. First, the Ohio Redistricting Commission adopted maps that appear to make the gerrymandered state districts worse. Committees have had hearings on a pair of bills, House Bill 322 and 327 that seek to address a problem that does not exist. House Bill 322 and 327 also attack academic integrity, freedom, and hurts state government diversity and K-12 education. There are bills being dubbed as "vaccine" freedom bills, House Bill 248 and 435, that could cause more harm than good. There are no forced vaccinations, and religious, medical, and good consciences exemptions already exist and are followed. A coalition of hundreds to businesses, insurance companies, health providers and many more have come out against these bills.

Attention on these bills are distracting from the issues Ohio should be focused on, such as expansion of Electric Vehicles. EVs are the future and each day become more widespread. If Ohio is not prepared, the EV production industry will continue to pass us by. Recently Ford announced a decision to build a new facility geared towards EV production in Tennessee. Five Midwest States formed a coalition to expand EV in the region and Ohio was left out. In the Statehouse, there are several bills that will help prepare Ohio's economy for EV including my bill, House Bill 292. HB 292 is a bi-partisan bill, joint sponsored by Rep. Cutrona (R-Canfield). House Bill 292 will establish a commission focused on laying the groundwork for Ohio to be competitive with the 49 other states to attract EV production. A large portion of our state's economy is linked to the automotive industry but we need to take steps to ensure those ties continue. October is Domestic Violence Awareness Month and while the COVID-19 pandemic appears to have exasperated the crisis, Domestic and Sexual Violence sadly is very prevalent in our state. As Chair of the Ohio Democratic Women's Legislative Caucus, I lead an incredible team of lawmakers who are focused and dedicated to ending domestic violence and opening pathways to allow survivors to seek justice. ODWLC members have introduced House Bill 121 to eliminate the Marital/Spousal Rape exemption. In Ohio it is legally permissible to rape your spouse because you are married. House Bill 199 removea the cap on damages awarded during court cases brought against the sexual assaulter or rapist. House Bill 266 will eliminate the statue of limitation to bring criminal and civil action against sex crimes.. Additionally, the ODWLC is partnering with likeminded advocacy groups to introduce more legislation that will address other aspects of domestic and sexual violence.
