Dear Neighbor,

The redistricting process continues, after the Ohio Supreme Court struck down both the state legislative and Congressional maps as unconstitutional in mid-January. The Court gave the Ohio Redistricting Commission 10 days to redraw the state legislative maps, and Republican commissioners adopted another set of partisan, four-year state maps on Jan. 22 without any Democratic support. The new state maps were struck down again by the Court after voter rights advocates challenged the new maps as unconstitutional.

Our democracy should work for and include all of us. But a handful of Redistricting Commission members blatantly ignored what Ohio voters told us they wanted, not once, but twice. Democrats continue to believe that Ohioans are entitled too deserve fair, constitutional maps.

In response to the uncertainty caused by the unconstitutional state legislative and Congressional maps, House Bill (HB) 93 was recently signed into law, which makes several changes to the filing requirements for the upcoming primary election.

The emergency legislative changes enacted will help alleviate some concerns about administrative deadlines and paperwork requirements, but these measures fall far short of what's needed to prevent chaos and confusion for election officials and candidates. This could have been avoided entirely had Republican commissioners passed fair, constitutional maps the first time.

Ohio House Democrats are still fighting to ensure fair maps and elections for the people of Ohio, who deserve to choose who represents them, not the other way around.

CDL Student Aid Program: There is still time to apply! Qualified institutions with CDL programs can apply at https://www.ohiohighered.org/cdl through Feb. 18, 2022. The CDL Student Aid Program is an economic driver and will help to fill essential roles in our state's supply chain, as well as snowplow and school bus driver shortages. Rep. Sobecki worked with colleagues on both sides of the aisle and industry to establish this program. Rep. Sobecki joint sponsored House Bill (HB 129) to establish the CDL Student Aid Program in Ohio. The CDL Student Aid Program was included as a budget provision and signed into law by Gov. DeWine.
