## Lorain County Crisis Receiving Center Site Visit

The planning and construction of the Lorain County Crisis Receiving Center has been a joint effort from many community partners: The Mental Health, Addiction and Recovery Services Board, the LC Board of Commissioners, Riveon Mental Health and Recovery (formerly LCADA Way and the Nord Center), and the Lorain County Community Foundation, to name a few. This Center will be the first of its kind in the county, offering a "no wrong door" approach for individuals facing mental



health or addiction crises. The facility will have 32 beds, 16 dedicated to mental health care and 16 for addiction recovery. In addition, it will be the new home to Lorain County's 988 Crisis Services center which handles over 2,000 calls monthly. Federal and state earmarks coupled with local levy funds and philanthropic support from the community has provided the necessary support to build this center, slated to open in September 2025.

## Fostoria Ethanol Plant Tour

I toured the Fostoria Ethanol Plant on Monday, October 7th. The state-of-the art bioethanol production facility consumes about 24 million bushels of locallygrown corn to produce 90 million gallons of bioethanol annually. As a member of the House Agriculture Committee and House Agriculture Finance Subcommittee, is it important for me to hear from businesses that partner with farmers and the community to bolster the economy through ethanol production.
