LEGISLATION TO WATCH

House Bill 657 – Enact the Transparency in Pledge of Allegiance "T.I.P.A" Act On August 19th, I introduced House Bill 657, which will require school districts to publicly disclose their Pledge of Allegiance policies.

<u>House Bill 254 – Regards Homestead Property Tax Exemption for Disabled Veterans</u>

I introduced House Bill 254 to help keep veterans in their homes, providing an 100% property tax exemption to veterans with 100% disability ratings.

<u>House Bill 230 – Regards Drug Trafficking, Organized Trafficking of Persons</u> House Bill 230 will save lives by increasing the penalties for drug and human trafficking in Ohio.

House Bill 681 - Regards the Medicaid Estate Recovery Program

This recently introduced legislation seeks to create transparency, by clarifying the scope of the Medicaid Estate Recovery Program.

<u>Senate Bill 313 – Alyssa's Law</u>

This legislation is a critical innovation to providing students with a safer learning environment. I also support the companion legislation that is being introduced in the Ohio House.
