Democrats highlight their "Support Our Seniors" legislation

Ohio House Democratic Caucus has legislation to counter rising costs and ensure older Ohioans on fixed incomes have economic security. The Support Our Seniors legislative package includes bills to reduce the costs of expenses such as healthcare, prescription drugs and utilities. The package would also put more money into the pockets of older Ohioans by lowering property taxes and reinstating cost-of-living adjustments for certain retirees.

- **HB 135**—Reduce the cost of prescription drugs
- **HB 305** Cap the cost of insulin at \$35 a month
- **HB 125** Enact the Pre-Existing Condition Protection Act
- **HB 57** Fully repeal HB 6, corrupt corporate bailout legislation costing Ohioans \$150 million per year
- **HB 260** Require refunds to improperly charged utility customers
- **HB 389** Re-establish energy efficiency programs that will save utility ratepayers money and reduce energy usage
- **HB 207**—Expand the Homestead Exemption Act

- HB 601

 Establish minimum cost-of-living adjustments for teachers and other school employees and increase employer contributions for the first time since 1988
- HB 562- Reinstate the cost-of-living adjustments for Ohio's retired teachers
- **HB** 79 Establish the Caregiver Expenses Tax Credit
