Legislative Updates

House Bill 546 Introduced in House Government Oversight Committee

Representative Gross recently introduced legislation to require all Ohio ballots to have a watermark. HB 546 would bolster election integrity and citizen confidence in the election process by discouraging the creation of fraudulent ballots. HB 546 awaits a hearing in the House Government Oversight Committee.



House Bill 547 Introduced

Representative Wiggam and Representative Gross introduced HB 547. This legislation would require those who apply for Low Income Housing Tax Credit (LIHTC) program funds appropriated by the operating budget to be legal residents of the United States. This change ensures that only Ohioans who are lawfully present in the United States will be able apply for these funds. HB 547 awaits a sponsor testimony in the House Economic Workforce and Development Committee.

House Bill 319 Received 2nd Hearing in House Health Provider Services Committee

The House Health Provider Services Committee recently held a hearing for proponent testimony on HB 319 – the Conscientious Right to Refuse Act. The Act will protect Ohioans who choose to decline a vaccine or pharmaceutical due to religious or conscientious beliefs from discrimination in the workplace and higher education.
