As your voice in the state legislature, I promise to work hard for you and your family every single day. I am excited to share more updates on legislation, committee work, and more in the months to come.



# STATE REPRESENTATIVE HUMPHREY'S OVERVIEW OF THE 135TH GENERAL ASSEMBLY

### **Legislation Signed into Law**

I'm proud to announce, in the 135th General Assembly several bills I championed have been signed into law by the governor:

**HB 50**: Creates a Certificate of Qualification for Housing, providing housing relief to returning citizens.

**HB 28:** Officially designates March as "Triple Negative Breast Cancer Awareness Month" to raise awareness and honor those affected by this aggressive form of cancer.

**HB** 7: Bill to address issues from Infant Mortality to Early Childhood Education for mothers and children across Ohio.

**HB 29:** Provides equitable alternatives for individuals facing driver's license suspensions, including payment plans and community service options.

#### **Honorable Mentions:**

Sponsored the Medicaid Doula Program, now included in the operating budget.

Sponsored continuous Medicaid enrollment for children aged o-3 included in the Operating Budget.

Sponsored \$5 million/year in reimbursements for psychotropics and withdrawal management drugs in community-based correctional facilities in the Operating Budget.

## Legislation Passed in the Ohio House

Some of our initiatives have passed the Ohio House with bipartisan support and will be reintroduced in the next General Assembly:

**HB 30:** Requires correctional facilities to provide feminine hygiene products.

**HB 114:** Allows candidates to pay for child care costs with campaign funds, increasing representation in the legislature.

#### **Budget Victories**

Through advocacy and collaboration, I was proud to secure vital funding for our district and statewide programs:

Sponsored the Medicaid Doula Program, now included in the operating budget.

Secured \$100.1 million for Franklin County through the capital fund for FY 25-26.

\$500,000 for the Eastland Prosperity Center development.

\$100,000 for Community for New Direction in capital funds.

\$500,000 for the Vista Villages Tiny Home Project.

\$3.3 million in capital funds brought back for FY 23-24.

Advocated for \$2.5 million allocated to the Healthy Beginnings

at Home Program, supporting stable housing initiatives for pregnant mothers.

Sponsored \$5 million for free period product dispensers in schools enrolling girls in grades 6-12 in operating budget.

Supported \$64.1 million in allocations for the Ohio Association of Foodbanks.

#### **Community Engagement and Outreach**

This year, we worked diligently to bring resources and opportunities directly to our community:

Hosted career fairs, connecting hundreds of residents to employment and essential services.

Coordinated multiple Senior Citizen resource fairs, bringing together over 20 senior and human service agencies.

Partnered with local organizations for community conversations, including the "Real Spill" initiative,

fostering mentorship for young Black men.

Held 2 small business roundtables, providing resources and grant information for local entrepreneurs.
