Rep. Humphrey calls for end to gun violence in House District 26

This week, **State Rep. Latyna M. Humphrey (D-Columbus)** issued the following statement after Columbus <u>surpassed 100 homicides</u> for 2022. 19 out of 101 homicides, or about 19 percent, of all Columbus homicides this year have happened in House District 26.

"The level of gun violence in our communities is completely unacceptable," said **Rep. Humphrey**. "Even one life lost to gun violence is too many. We have to crack down on this violence to ensure our streets are safer for all of our families. I will continue to do everything in my power to as an elected official to support my constituents who have been impacted by gun violence, including advocating for commonsense gun safety legislation that will keep our children and families safe."

Rep. Humphrey is committed to working with anyone to stop gun violence. A study published in JAMA Pediatrics found that gun violence disproportionately impacts young people in lowincome counties. More than 62% gun deaths occurred among youth ages 5 to 24 from 2007-2016.

Currently, there are <u>13 bills</u> in the legislature that would implement commonsense, gun safety, including House Bill (HB) 274, which would allow local governments to enact gun safety measures that are best for their communities.





Extreme legislation to make it easier for teachers to carry guns takes effect

In September, Republican legislation that allows teachers and staff to be armed in schools took effect. Law enforcement, teachers' unions, civil rights groups and students all strongly opposed this legislation.

Schools are the last place we need more guns. Arming our teachers puts students in more danger. Instead of this extreme legislation, our state should be focusing on gun safety solutions that reduce gun violence and keep our communities safe.

Ohio Democrats' commonsense gun safety bills include:

- HB 38- Repeal "Stand Your Ground"
- SB 73/HB 259— Universal background checks
- SB 76/HB 274— Restore local control to regulate firearms-related conduct
- SB 77— Ban bump stocks and other items that accelerate semi-automatic firearms
- SB 138/HB 257— Enact Extreme Risk Protection Order Act ("Red Flag" law)
- HB 262— Prohibit negligent firearm storage
- HB 360— Designate Gun Violence Awareness Month

• HB 661— Require gun trigger locks with firearm sales

I will proudly continue to support commonsense gun safety legislation that keeps communities safe, protects law enforcement, reduces violence, and protects the Second Amendment.
