Interested In HB195? Track It



I am very excited to share that on April 24, I passed my first bill out of the Ohio General Assembly and that it is now awaiting Governor Michael DeWine's signature. For those of you who read my monthly newsletter, you will recall that last May Rep. Steve Demetriou (R - Bainbridge Township) and I introduced House Bill (H.B.) 195. This bipartisan bill will create an adaptive mobility car dealer license in Ohio. Currently, car dealers who retrofit vehicles for the disabled community are operating in a gray area under Ohio law. H.B. 195 will clear up this area of the law to the benefit of legitimate car dealers and those they serve. Our bill will lead to more adaptive dealers entering the market and result in better quality, lower prices, more choices, and further innovations in the adaptive automobile space. In fact, our bill will benefit disabled and senior Ohioans in many ways, including giving them peace of mind that the vehicles they purchase are safe and reliable and that the vehicle warranties will be honored.

Making a state law is a very difficult process, which is why very few bills actually become law. After many meetings and calls with interested parties, Rep. Demetriou and I introduced H.B. 195 in May, 2023. It was then assigned to the Ohio House Committee on Commerce and Labor, where, after several hearings, it passed unanimously in October. It was then sent to the full House for a vote and passed 88-1 in December. Next, it was sent to the Senate Transportation Committee for hearings. It passed that committee unanimously on April 24. On that same day, it was passed by the full Senate 32-0. Because the bill was amended slightly in the Senate, it had to be passed again by the House, which was done a couple of hours later. A bill moving that quickly in one day is highly unusual, but it is testament to the hard work my colleague and I put in, a lot of help from a lot of folks, and the bipartisan nature of the bill.

Rep. Demetriou and I came to the General Assembly together in January, 2023, as freshmen. Our success is proof that bipartisanship is still alive and gives me hope for the future. We look forward to meeting with Governor Michael DeWine for an official bill signing ceremony.

Since I joined the Ohio General Assembly in January, 2023, 1,600 bills have been introduced with 20 becoming law. That's about a 1% chance of a bill becoming a law, which makes H.B. 195 particularly special.




#### State Rep. Brennan Supports Property Tax Relief Bills

- H.B. 60 Increase the Amount of and Expand the Homestead Exemption
- H.B. 187 Modify procedures to conduct property tax sales-assessment study
- H.B. 254 Regards homestead property tax exemption for disabled veterans
- H.B. 263 Authorize a property tax freeze for certain owner-occupied homes
- H.B. 274 Authorize enhanced homestead exemption for certain homeowners
- H.B. 378 Permit homestead exemption-surviving spouses of service members
