Dear Neighbors,





2025 LEGISLATIVE RECAP

DURING THE 2025 LEGISLATIVE SESSION,
REPRESENTATIVE THOMAS INTRODUCED 14 BILLS:



TWO PASSED THE HOUSE UNANIMOUSLY

[House Bill \(HB\) 3](#), the "School Bus Safety Act," is a bipartisan bill that passed unanimously on the House floor on June 11, 2025. We are hopeful that the second hearing for the bill will take place sometime in 2026.

[House Bill 247](#), "Avery's Law," was signed into law by the governor on December 19, 2025.

Originally introduced as House Bill 240, the bill was sponsored by Representatives Thomas and Lawson-Rowe. During the committee process, it was combined with Representative K. Miller's bill.



AND TWO WERE SIGNED INTO LAW BY THE GOVERNOR.



[House Bill \(HB\) 359](#), "The Joshua Alert," passed the House unanimously on November 12, 2025. A bipartisan bill, it is a top priority for Rep. Thomas, who will push for its passage in the new year.

[House Bill 4](#), Designating Ohio Stillbirth Prevention Day, was a bipartisan bill that passed unanimously through both the Ohio House and Senate. It was signed into law by the governor on May 28, 2025, and officially went into effect on August 27, 2025.



ADDITIONAL BILL HIGHLIGHTS:

[House Bill 46](#), the Extreme Risk Protection Order Act, is a red flag law introduced by Rep. Thomas and is awaiting its first hearing. He firmly believes that bills like this are essential for making Ohio safer.

[House Bill 110](#) increases penalties for repeat voyeurism, also known as "peeping Tom" activity. This bipartisan bill is currently awaiting its first hearing in the Ohio House of Representatives.

[House Bill 452](#) designates October 1st as [761st Tank Battalion Day](#) to honor the first all-Black battalion in WWII. Rep. Thomas and Rep. Lawson are planning a Black History Month event to further highlight the bill's significance.

[House Bill 337](#) requires federal firearm dealers to include trigger locks with firearm sales and offer additional gun locks or locking devices to purchasers. The bill is still awaiting its first hearing.

LETTER TO TriHealth and UnitedHealthcare

The Democratic Cincinnati delegation of Ohio State Representatives and Senators sent a letter to TriHealth and UnitedHealthcare expressing concerns that UHC might force TriHealth out of network, leaving thousands without affordable healthcare after December 31.

The letter called for continuity of care. Rep. Thomas is pleased to announce that an agreement has been reached, ensuring that TriHealth hospitals, outpatient centers, and physicians remain in-network for UnitedHealthcare's employer-sponsored,

Medicare Advantage, and Medicaid plans. This agreement guarantees uninterrupted care for UnitedHealthcare Commercial, Medicare Advantage, and Medicaid patients, allowing them to schedule appointments as usual.



GUN VIOLENCE PREVENTION CAUCUS

Representative Thomas is the Co-Chair of the Ohio Gun Violence Prevention Caucus. Over the past year, the caucus has met several times to build relationships with organizations like Students


Demand Action and OnCall4Kids. The goal is to create a strong legislative framework to address gun violence in Ohio. Rep. Thomas hopes to see this come to fruition in 2026.

THE ATTACK ON MIGRANTS IN OHIO:

As Ranking Member of the Ohio House Public Safety Committee, Rep. Thomas has witnessed many harmful immigration bills come through the committee, particularly House Bill 1, the Enact Ohio Property

Protection Act. This bill would essentially make Ohio unwelcoming to immigrants, regardless of their legal status. Rep. Thomas partnered with the Asian American Coalition to protest the bill on June 24, 2025,

and plans to continue fighting against this and similar harmful legislation in 2025. Ohio should remain a safe and welcoming place for the thousands of immigrants who call it home.



BILLS THAT RAISE RED FLAGS:

Senate Bill 172 requires state and local public offices and officials to allow the arrest or detention of migrants suspected of being unlawfully present in the U.S. This could lead to racial profiling and discrimination.

Senate Bill 303 would allow 18-21 year-olds to purchase handguns in Ohio. Given that this age group is already the most negatively impacted by firearms, providing more access to weapons is a step in the wrong direction.

House Bill 410 blocks federal funding for nonprofits providing family planning, reproductive health, and medical care to low-income, underserved individuals. Since federal funds already don't support abortion clinics, this bill adds unnecessary barriers.


Senate Bill 293 cuts the four-day grace period for mail-in ballots, risking voter disenfranchisement due to mail delays. The bill is already law—stay informed as elections near.

GETTING AHEAD: WHAT IS THE CAPITAL BUDGET?

The Ohio Capital Budget provides funding for the construction, renovation, and equipment of state facilities, as well as grants for local businesses and cities to support their projects. The focus is typically on projects that are ready to move forward, with the understanding that additional funding sources will be involved as well. This process will begin at the state level in 2026, though the rules are still being finalized. In the meantime, I encourage you to think about any potential projects in the district that might qualify. Once the application process is officially underway, my office will make sure to keep you updated. Please don't hesitate to reach out if you have any questions.
