## Agriculture Support: Budget Edition

In the 2026–27 biennial budget, Ohio made significant investments to strengthen agriculture, with the Ohio Department of Agriculture receiving \$361.7 million over two years. This includes \$121.3 million for H2Ohio, helping farmers adopt conservation practices to improve water quality. Funding for soil and water conservation districts rose from \$7 million to \$12.5 million annually, supporting nutrient management and soil testing.

The budget also expands animal health programs and funds the Ohio State College of Veterinary Medicine to address the rural vet shortage (see below). Additionally, it provides \$10 million for the Animal Disease Diagnostic Laboratory, benefiting livestock producers and safeguarding farm data.

Overall, these investments underscore Ohio's commitment to both farm productivity and environmental stewardship.

### **Pest Alert**

The Ohio State University Extension in Delaware County is advising farmers about red crown rot, a fungal disease affecting sovbean plants. So far it has only been spotted in Delaware County. The red crown rot fungus actively infects soybean roots when soil temperatures are between 77 and 86°F, so the planting date and associated soil temperature also may influence red crown rot severity. Cleaning equipment to remove soil before moving to a new field may also help reduce the spread of the red crown rot fungus to a new field. https://tinyurl.com/vjysv8sk



#### **Wheat Alert**

Wheat growers are facing growing uncertainty driven by low prices, high input costs, and volatile weather. Global oversupply and weaker export demand have squeezed profit margins, while unpredictable rain and disease pressures — like head blight — make crop management more difficult. Trade tensions and shifting international markets have further clouded price outlooks, and delays in crop insurance or government payments have left many farmers without reliable safety nets. #### Looking for Veterinarians

Future veterinarians can earn their degree with major financial support through the Health Professions Scholarship Program (HPSP). Offered primarily by the U.S. Army, this program covers full tuition, reimburses fees and equipment costs, and provides a monthly living stipend for students in AVMA-accredited veterinary programs.

In return, participants serve as commissioned officers in the Army Veterinary Corps — typically one year for each year of scholarship support. While other benefits like the GI Bill and Tuition Assistance can help, HPSP is the most comprehensive option for those looking to combine a veterinary career with military service.
