Budget Update

House Bill 96, the Biennial State Operating Budget has now been signed into law by Governor DeWine. I opposed this partisan budget because it prioritizes tax breaks for the wealthy and corporate giveaways over funding for schools, affordable communities, and essential healthcare services. Despite a few helpful line-item vetoes, the budget still overwhelmingly reflects out-of-touch priorities that leave everyday Ohioans behind. However, this process is not done. Speaker Huffman has scheduled a House Session on Monday, July 21 for the purpose of considering overriding some of the Governor's line-item vetoes. The following items pertaining to property tax reforms will be considered at this session, and if the override is successful would be added back into the budget:

- Item Number 55 Property Tax: County Budget Commission Authority & Procedure
- Item Number 65 20-Mill Floor Calculation
- Item Number 66 School District Property Tax Levy Restrictions

A veto override would require a 3/5 majority vote, which is 60 in the House. Other items may be considered at future scheduled sessions any time during this General Assembly.

A budget reflects the choices we make about our values and priorities. The Republican majority in this state chose to prioritize tax breaks for the wealthiest Ohioans instead of investing in families, children, our oldest Ohioans, education, and healthcare. Instead of investing in our future, this budget deprives people and communities of the resources they need to thrive. This budget will hurt Ohio's students by putting our system of public education at risk by not adequately funding our schools.

I am grateful to individuals from across this state who came to testify about the damage this budget will do to individuals and local communities across Ohio. I am also grateful to the countless Ohioans who reached out to legislators and the Governor. Your efforts had an impact and are reflected in the historic number of line-item vetoes the Governor issued. Please stay engaged because the work is not done. We will need your voice and your energy even more moving forward.

This budget does not reflect my priorities nor the priorities of our district. Instead, it is a partisan wish list that will set our state backwards. This budget fails Ohioans of all ages, in all communities, and of all backgrounds.

House Bill 335 is not a solution to fixing Property Taxes

Last month, I joined colleagues and community partners for a press conference condemning <u>House Bill (HB)</u> 335.

HB 335 proposes major changes to revenue options for local governments to cut property tax collections in the guise of "relief," mostly benefitting the wealthy while harming our communities and local governments.

Property tax relief should be targeted, need-based, and state-funded. There are numerous, bipartisan proposals that cut property taxes for homeowners while keeping schools and local governments whole, including:


- · Authorizing property tax freeze for certain owner-occupied homes (Isaacsohn, T. Hall)
- · Enacting the Property Tax Refund Act (Brennan, D. Hall)
- · Authorizing property tax exemption for certain long-term homeowners (Brennan, Mathews)
- · Increasing the homestead exemption amount and income limit (Troy, T. Hall)
