# Primary Election



Reminder to make a plan to vote in the upcoming primary election on Tuesday, May 6!

There are several issues on the ballot this Spring, including:

#### Statewide:

 Issue 2, which would permit up to \$250M per year over the next decade to support the Ohio Public Works Commission Capital Improvement Program.

The Ohio Public Works Commission has funded infrastructure projects in communities throughout Ohio for nearly 40 years. It provides grants and loans for better roads, bridges, wastewater treatment, water supply, and stormwater infrastructure. The program does NOT increase taxes and is reliant on bonds which are paid off with existing state revenue.



#### Local


- Three candidates will be vying for the Columbus City Council District 7 seat previously held by current Franklin County Prosecutor Shayla Favor. The top two will advance to the general election.
- Ten candidates are vying for three seats on the Columbus City School Board of Education. The top six candidates chosen this May will advance to the November election.
- (Issue 12): The Village of Lockbourne will, again, have a proposal on the ballot to increase its income tax to 2.5%, with an 1.5% allowance credit for income paid to an employer jurisdiction.
- (Issue 18): Hamilton Township will have a five-year renewal police levy on the ballot for both incorporated and unincorporated residents. It is important to note that renewal levies maintain the same millage as the most-previous passed levy, therefore, this proposal, if passed, will not increase property taxes.
- (Issue 24): Groveport Madison Local School District will have a bond issue on the ballot to authorize \$77.2M in bonds to construct, improve, furnish, and equip three new middle schools and an addition to Groveport Madison High School.

Early voting is **now** until Sunday, May 4, at the Franklin County Board of Elections, 1700 Morse Road. Mail-in ballots must be postmarked by Monday, May 5 to be counted. Polls open at 6:30 a.m. on May 6 and close at 7:30 p.m. Remember that you can still vote if you are **in line** at 7:30 p.m. on Election Day!

### Rep. Lawson-Rowe Is Working For You

I am proud to announce that I have introduced the following legislation this General Assembly:

- HB 104, with Rep. Kellie Deeter (R-Norwalk), to designate February 14 of each year as "Cardiovascular Awareness Day".
- HB 135, with Rep. Terrence Upchurch (D-Cleveland), to prohibit income-based rental discrimination.
- HB 166, with Rep. Josh Williams (R-Sylvania Twp.), to designate March 10 each year as "Harriet Tubman Day", which was voted out of the House Government Oversight Committee and now awaits a vote on the House floor.
- HB 181, with Rep. Jamie Callender (R-Concord), to establish an indigent defense fund in Ohio to aid in the defense of persons facing evictions who cannot afford a lawyer.
- HB 235, with Rep. Darnell Brewer (D-Cleveland), to authorize a nonrefundable income tax credit for the cost of a firearms training or recertification course, or for the cost of a secure storage or lock box for a firearm, not to exceed \$250.00.
- HB 240, with Rep. Cecil Thomas (D-Cincinnati), to enact "Avery's Law" which would revise the current dog laws in our state to offer more accountability to owners of dogs who attack, more mechanisms for certain authorities to enforce dog laws and to create serious criminal penalties to owners whose dogs attack humans and companion animals.
- HB 241, with Rep. Cecil Thomas (D-Cincinnati), to authorize the quarantine of dogs who attack while an investigation is held, and would allow that investigation authority to determine the culpability of a dog and its owner in an attack.
- HB —, with Rep. Cecil Thomas (D-Cincinnati), to authorize a nonrefundable income tax credit for the cost of spaying or neutering a dog, or for a completed dog training or obedience course, not to exceed \$350.00.

As mentioned, future legislation is forthcoming regarding property taxes and maternal health and infant mortality.

### **Legislative Update**

On April 9, I voted "no", along with 38 of my fellow colleagues, both Democrat and Republican, on House Bill 96, the state operating budget for fiscal years 2026-2027. I deliberated long and hard before casting my dissenting vote. My decision ultimately came from the reality that this budget arbitrarily and recklessly slashes critical state funding areas while failing to benefit everyday Ohioans.

Ohio's operating budget is reflective of our priorities as a state. The House's version of this budget makes it evident that everyday Ohioans are not the priority. Among a litany of issues, this budget asks public schools to do more with less by deviating even further from the fair school funding formula, forgoes and forsakes accountability in campaigns and elections by abolishing the Ohio Elections Commission, risks the healthcare of nearly one million Ohioans by peeling back the layers of the successful expansion of Medicaid, and so much more. The budget is unfair, unsustainable, and, vet completely avoidable.

I pledge to continue fighting so that we can send a real, people's first budget, to the Governor's desk.
