I am saddened to share that House Bill 96, the proposed operating budget for FY 2026-2027, has been signed into law by Governor DeWine. I voted **NO** on this budget because it is a harmful, partisan state budget that slashes vital services while handing \$600 million to billionaires for a new Browns stadium. HB 96 will risk Medicaid enrollment for nearly 800,000 people in Ohio. 53% of my constituents rely on Medicaid, and I will not stop fighting for their rights and safety. Simultaneously, it implements tax breaks for the wealthiest Ohioans. Under this budget, less than a third of my constituents will benefit from tax relief.

While this budget is detrimental to Ohioans, the Governor overrode his Republican colleagues to preserve certain things. He partially vetoed provisions that would have punished social services that support our LGBTQ community, cut from the bill a part that would have hurt babies ages 0-3 on Medicaid, and language that restricted libraries. **One win for our district, specifically, is funding for The Refuge Ohio**. The budget includes \$500,000 to the local nonprofit that serves men in recovery, \$250,000 per fiscal year.

Now that the Operating Budget has been signed, we are looking forward to working on the Capital Budget. Please reach out to my office if you have any requests.
