

This month I voted against restrictions on school district property tax levies, after this budget provision was vetoed by the Governor. Unfortunately, the veto override for this line item still passed thanks to the Republican majority under the disguise of "property tax relief".

Real Property Tax relief is a pressing issue, and by overriding this veto, the Republican majority has disregarded the needs of Ohioans. Eliminating levy options restricts communities' abilities to choose how they support their public schools. If a community's ability to fund essential services is limited, it will force school districts into constant funding crises. These are not reforms, but dangerous actions that will create more serious consequences by cutting vital services.

I am fully committed to standing up for my constituents and fighting for their needs, and, right now, what they urgently need is real property tax relief.
