ASCVB Partnership in Motion Holiday Celebration

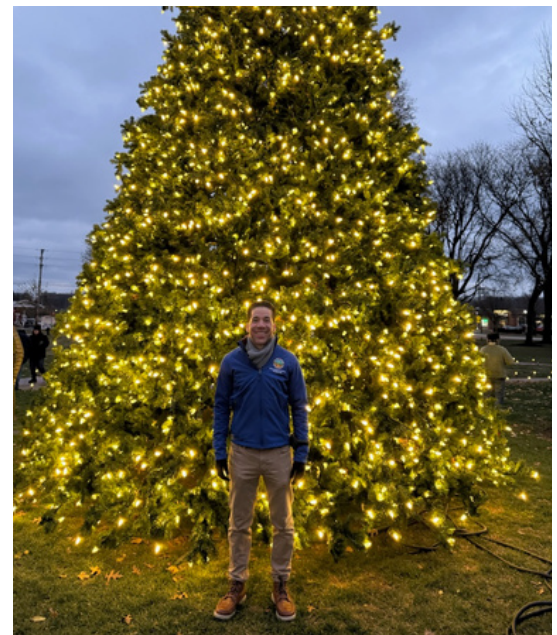

I am also hopeful that our unity and dedication to our constituents will bring progress and growth in the new year. 2026 will be a year full of hard work and collaboration, but I am optimistic about the opportunities ahead.



The Capital Budget

As we begin the second (and final) year of the 136th General Assembly, I wanted to share some information about what is to come. In 2025, we decided on Ohio's operating budget. In 2026, we will go through a process to decide on the **capital budget**. While the operating budget funds core functions and services, the capital budget funds **physical projects, like infrastructure, schools, parks, and more**. My role as a legislator is to meet with agencies and organizations to hear about and review their project goals and proposals. Once these requests for funding are decided on, approved, and submitted, Governor DeWine will introduce the budget as a bill, and it will go through the legislative process to be passed.



Senate Bill 56

SB 56 goes against the will of voters, who voted to decriminalize cannabis with Issue 2 in the November 2023 election. I voted against it. However, **SB 56** was recently passed into law, and will go into effect in March of 2026. **Let's review what the bill does:**

- SB 56 makes it illegal to obtain cannabis outside of Ohio or take it across state lines.
- The bill implements a ban on intoxicating hemp products sold outside of a licensed marijuana dispensary, causing many small businesses to close.
- SB 56 prohibits possessing marijuana in anything besides its original packaging, and it must be stored in the trunk of a car while driving, along with any paraphernalia.
- The bill caps the number of dispensaries in Ohio at 400.
- Areas where it is prohibited to smoke or vape will be expanded.
- The bill increases criminal penalties for many of these regulations.



Primary Election Day on May 5th, 2026

Please note Ohio's Primary Election takes place on **May 5th**. Make a plan to vote on that day, and don't hesitate to reach out to my office or the Summit County Board of Elections if you need assistance finding information and resources. Visit **VoteOhio.gov** to find your sample ballot and polling location, track your absentee ballot, check your registration status, learn about ID requirements, or become a poll worker! Every vote counts. Make your voice heard this year!
