A Legislative Update from the Office of State Rep. Erika White



Dear Neighbor,

Summer is nearly over, but Ohio is not cooling off—in fact, we’re leading the way in the redistricting battle. While Texas Republicans just rammed through a mid-decade congressional map aimed at securing five additional GOP seats for the 2026 midterms, we’re doubling down on fairness here at home.

Ohio has already shown what leadership looks like:

- *We passed reforms by overwhelming margins in 2015 and 2018, with nearly 75% of voters demanding transparent, bipartisan maps under Article XIX of our state constitution .*
- *We’ve forced courts to throw out multiple extremist maps, proving the system can only work when it’s held accountable.*

Now, House Democrats in Ohio are stepping up with renewed energy to guarantee fair maps—not legislated gerrymanders. Because when voters draw the lines, democracy wins. Voters should choose their politicians—not the other way around.

Ohioans led the fight. The job isn’t done. Let’s finish it.

Ohio is next and the outcome will Impact our state for generations. Ohio already has some of the most rigged districts in the country which has led to single party rule, out-of-teach leadership, and dangerous federal bills that directly impact Ohioans’ Medicaid coverage, hospitals, and food stamps. That’s not democracy.

Fair districts = fair representation. Rigged maps cheat voters out of real choices. House Democrats are fighting to ensure every Ohioan—and every community—has a seat at the table.
