

Auditor Faber,

We, the undersigned members of the Ohio House of Representatives, write to you today to request an investigation into recent allegations made by members of the public regarding potential fraud and abuse of publicly funded childcare and home health care entities. After news broke exposing the \$10 billion fraud network in Minnesota, we have heard from citizens raising concerns about similar fraud that may be happening in our state. These allegations raise reasonable concerns that highlight irregularities and suspicious activity that are discernible from a simple online search.


Americans deserve to have faith that their tax dollars allocated to childcare and home healthcare for seniors and Ohioans with disabilities are being used appropriately. Transparency and accountability are critical to rebuilding public trust in the aftermath of the massive fraud being uncovered in other states.

If there is any waste, fraud, or abuse, then we owe it to the people of Ohio to resolve this matter as quickly as possible, especially with so many citizens bringing it to our attention. We respectfully request that immediate action be taken to ensure these programs are not being abused and ensure the people of Ohio can rest knowing their tax dollars are being used correctly.

If this is not the case, we also request that you refer findings over for prosecution, where applicable. We would also request that any programs that are found to have been manipulated be reported so that those programs to be subject to future loss in funding and policy changes to ensure that Ohioans in need are cared for effectively and efficiently. We stand ready to assist with this matter to the furthest extent of our legislative authority.






